### Ingérop wins a major contract in Montenegro in the infrastructure sector

During a ceremony held on Thursday, September 11th, 2014 in Podgorica, capital of Montenegro and in the presence of Mr. Ivan Brajović, Minister of Transport and Maritime Affairs, Ingérop, as leader of a consortium comprising its Italian partner Geodata, was awarded the supervision of the construction of 41 km of highway to be constructed by a Chinese company between the cities of Smokovac and Matesevo. Eventually, the highway will link the cities of Bar and Boljare, hence connecting Serbia to the Adriatic Sea.
